



Next Level Golf LLC Membership Agreement

This Membership Agreement (“Agreement”) is entered into by Next Level Golf LLC (“Organization”) and _____ (“Member”), and comes into effect as of _____.

1. Member Benefits

As a part of this membership with Next Level Golf LLC, the Member will receive the following benefits for a fee of \$199 per month:

- 32 hours of simulator (SIM) play each month, to be used on non-peak days, which is currently designated by the Organization as Monday through Thursday (excluding holidays) and based on SIM time availability. SIM time must be reserved online through www.GoNextLevelGolf.com.
- The 32 hours of SIM play can be shared with guests, including friends, family, co-workers, etc., which will be designated by said member.
- Members receive priority booking which allows them to schedule tee times up to 4 weeks in advance.
- Members will receive 20% off the hourly SIM rate on peak days, which is currently designated by the Organization to be Friday through Sunday, including Holidays, and based on SIM time availability. SIM time must be reserved online through www.GoNextLevelGolf.com. Discount valid for members only, not member’s guests, and cannot be combined with any other offer.
- No reservation deposit required for SIM play on peak days and holidays.

2. Member Dues

Initial payment of \$199 is due upon signing of this Agreement, in which Member and designated guests can immediately start redeeming allotted monthly SIM play, based on SIM time availability. Thereafter, Member agrees to pay the Organization \$199 each month via autopay with a viable credit card. The autopay due date will be on the same date as this Agreement each month thereafter until Member provides a written termination notice to the Organization. If payment to credit card is rejected when processed on monthly due date, no hours will be allotted until valid payment is received by the Organization from the Member.

Due date example, if the Membership Agreement is executed on the 12th of the month, the monthly autopay date will be the 12th of every month thereafter. A new allotment of 32 hours will start over on the 12th of each month. Any unused hours from the previous month will not roll over.

3. Tee Time Reservation Policy

Reserved tee time must be canceled prior to 24 hours of scheduled time or reserved time will be forfeited from monthly allotted hours.

4. Liability

The Member will not hold the Organization liable for any tangible or intangible damage that might happen to them while participating in the membership.

5. Privacy

The Organization will not share any contact or personal information about the Member with other members, non-members or any third parties.

6. Membership Termination

The Organization has a right to modify and/or terminate this Agreement at any time, for any reason, and without notice.

Member can terminate this Agreement at any time with a written notice to the Organization. Written notice can be sent via US Mail to Next Level Golf LLC at 3910 Wayne Ave #110 Wichita Falls, TX 76308 or emailed to Play18@GoNextLevelGolf.com. Upon the Organization receiving written termination notice, any and all hours remaining on said Membership will be terminated and will not be available for use. Written termination notice must be received at least 14 days prior to monthly due date, if not, 1 remaining month of dues will be processed as scheduled and member will be able to use that last months of purchased hours.
